

DOMINICAN REPUBLIC

The Xyngular President's Club 2018 trip to the Dominican Republic includes airfare, transportation to and from airport to hotel and group activities, group excursions/activities and hotel accommodations for two people per qualifying account¹. A guest is a spouse or adult family member and cannot have a benefit in another Xyngular business.

Trip Point Requirements

- 100 Points • Trip²
- 150 Points • Trip + \$300 room credit
- 200 Points • Trip + Additional night³
- 250 Points • Trip + Another additional night

Additional Trip Qualification Requirements

- 4 Points • Monthly requirement⁴
- 20 Points • New Manager Category
- 4th Quarter Manager Maintenance
- 2 New Managers Advance To Silver Manager

Quarterly Recognition Point Requirements

- 25 Points • Quarterly recognition⁵

How To Earn Points

- 3 Points • Inception Volume⁶
- 5 Points • New Manager⁷
- 1 Point • Manager Maintenance⁸
- 10 Points • New Silver Manager⁹

¹Qualifiers from markets outside the US, Canada, and Puerto Rico earn a trip for one. They may bring a guest at their own expense.

²Only 60 points of the 100 qualifying you for the trip can come from Inception Volume points.

³Additional night's stay - room and tax

⁴Must have a minimum of 4 points in all but two months.

⁵Must earn 25 or more points in a given quarter. Quarter 1 is Oct-Dec, Quarter 2 is Jan-Mar, Quarter 3 is Apr-Jun, and Quarter 4 is Jul-Sep.

⁶Inception Volume per 1,000 points in a calendar month.

⁷New Manager points will be awarded for frontline Distributors that advance to the rank of Manager or higher during the qualification period.

⁸A Manager who first becomes a Manager during the period is considered maintained if they hit the rank of Manager or higher in subsequent months during the qualification period.

⁹Silver Manager points will only be awarded for accounts who first qualify as a new Manager during the qualification and subsequently advance to the rank of Silver Manager or higher during the qualification period. Accounts that were ranked as Manager prior to Oct. 1, 2016 will not count toward this point category.



Rules

Qualification Period: October 1, 2016 – September 30, 2017

1. Must have a valid Autoship order with a minimum of 120 PV every eligible month to qualify for the trip and quarterly event recognition.
 - Distributors who enrolled in Xyngular prior to October 1, 2016 must be on Autoship with at least 120 PV every month.
 - Distributors who enroll after October 1, 2016 must be on Autoship with at least 120 PV in every month following their inception month. For example, if a new distributor enrolls in January, they would need to be on Autoship starting in February through the end of the qualification period.
2. To qualify for the trip and any upgrades, Distributors must achieve total required points (100 or more) and have a minimum of 4 points in all but two months of the qualification period.
 - Distributors who joined Xyngular prior to Oct. 1, 2016 must meet this requirement 10 out of 12 months.
 - Distributors that join after Oct. 1, 2016 need to hit all but two of their eligible months after their inception month. For example, a distributor who joins in February would only need to meet this requirement in 5 out of 7 months.
3. During the qualification period, Distributors must have a minimum of 20 points from the New Manager category. At least 4 of those new Managers must hit or maintain Manager, or above, at least one of the months during the final quarter of the period (July-September 2017).
4. Distributors must help 2 of their new Managers advance to the rank of Silver Manager during the qualification period.
5. Qualifiers from the US, Canada, and Puerto Rico earn a trip for themselves and a guest. A guest is a spouse, significant other, or immediate family member over 18 years old. Guest cannot have a beneficial interest in another Xyngular account.
6. Qualifiers from markets outside the US, Canada, and Puerto Rico earn a trip for one. They may bring a guest at their own expense.
7. Inception volume is calculated as all orders placed within a new enrollee's inception month. Inception month is the calendar month in which the Distributor or Member enrolls. If the original inception order is greater than 360 PV then the entire order will count toward the enroller's inception volume requirement. However, if the original inception order is less than 360 PV and a Distributor or Member places additional orders during their inception month a maximum of 360 PV will count toward the enroller's inception volume requirement.
8. The President's Club trip, associated upgrades, and other benefits are non-transferable. Open to all Xyngular Distributors. No cash value.

Event Recognition Rewards

Quarterly Recognition Requirement: 25 Points

- Free attendance for one to the next companywide event. Qualifiers from quarters 1 and 2 will receive a free registration to Xyngfling and qualifiers from quarters 3 and 4 will receive a free registration to Xyngfest.
- If a Distributor meets the point requirement in both quarters they will receive free attendance for two.
- Special President's Club lanyard* and badge.
- President's Club ribbon* on event name tag recognizing the quarter of qualification.
- Invitation to an exclusive President's Club Luncheon* with special product gift.
- Red Carpet pictures.
- Reserved seating in a main event session.
- Special onstage event recognition.

Additionally, any Distributor that meets the quarterly point requirement will be included in our lead distribution cycle for the next 3 months following the quarter in which they qualified. For example, if a Distributor qualifies in the 2nd quarter of the qualifying period (Jan-Mar) they would then be included in the lead distribution process from April to June.

*Only for those listed on qualifying account.
